



UPK ELIGIBILITY

"HALF-DAY" MEANS FIFTEEN TO TWENTY (15 TO 20) HOURS OF PRESCHOOL

• All children who are four on or before 10/1 are eligible for a half-day program.

"FULL-DAY" MEANS THIRTY TO FORTY (30 to 40) HOURS OF PRESCHOOL SERVICE.

• Children that are four on or before 10/1 AND have one qualifying factor are eligible for full-day program.

"PART-TIME OR SLOT" MEANS TEN (10) HOURS OF PRESCHOOL SERVICE.

• Children that are three by 10/1 and have at least one qualifying factor are eligible for at least 10 hours of program





UPK ELIGIBILITY

To be eligible for additional preschool, a child must meet one or more of the following qualifying factors:

- Household is at or below 270% FPL
- Child is a dual-language learner and language spoken in home is not English, or the child's native language is not English
- Child has an IEP
- Child is currently in the custody of a state supervised and county administered foster care home or in non-certified kinship care
- Child is identified as homeless and lacks a fixed, regular, and adequate nighttime residence



UPK RATES

"For families enrolled in a preschool program for more than the number of hours covered the per-child rate will act

as a tuition credit available to all families enrolled in a participating preschool program."

- Formula set in rule, includes factors such as cost of highquality care, cost of personnel, cost of living, geographic factor, etc.
- Rate set for each LCO area using formula
- LCOs, County Human Services Departments, and other early childhood focused agencies will need to find ways to layer funding for families (CCAP, local tuition assistance programs, Head Start)
