To make a correction in a race with more than one candidate, draw a bold line through the oval and candidate name marked by mistake, then fill in the oval next to the correct name. If you voted for the only candidate in a race and want to withdraw that vote, you must request a replacement ballot.

WARNING: Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. Proposition FF (STATUTORY)

SHALL STATE TAXES BE INCREASED \$100,727,820 ANNUALLY BY A CHANGE TO THE COLORADO REVISED STATUTES THAT, TO SUPPORT HEALTHY MEALS FOR PUBLIC SCHOOL STUDENTS, INCREASES STATE TAXABLE INCOME ONLY FOR INDIVIDUALS WHO HAVE FEDERAL TAXABLE INCOME OF \$300,000 OR MORE BY LIMITING ITEMIZED OR STANDARD STATE INCOME TAX DEDUCTIONS TO \$12,000 FOR SINGLE TAX RETURN FILERS AND \$16,000 FOR JOINT TAX RETURN FILERS AND, IN CONNECTION THEREWITH, CREATING THE HEALTHY SCHOOL MEALS FOR ALL PROGRAM TO PROVIDE FREE SCHOOL MEALS TO STUDENTS IN PUBLIC SCHOOLS; PROVIDING GRANTS FOR PARTICIPATING SCHOOLS TO PURCHASE COLORADO GROWN, RAISED, OR PROCESSED PRODUCTS, TO INCREASE WAGES OR PROVIDE STIPENDS FOR EMPLOYEES WHO PREPARE AND SERVE SCHOOL MEALS, AND TO CREATE PARENT AND STUDENT ADVISORY COMMITTEES TO PROVIDE ADVICE TO ENSURE SCHOOL MEALS ARE HEALTHY AND APPEALING TO ALL STUDENTS; AND CREATING A PROGRAM TO ASSIST IN PROMOTING COLORADO FOOD PRODUCTS AND PREPARING SCHOOL MEALS USING BASIC NUTRITIOUS INGREDIENTS WITH MINIMAL RELIANCE ON PROCESSED PRODUCTS?

Shall there be a change to the Colorado Revised Statutes requiring that the ballot title and fiscal summary for any ballot initiative that increases or decreases state income tax rates include a table showing the average tax change for tax filers in different income categories?

Shall there be a change to the Colorado Revised Statutes reducing the state income tax rate from 4.55% to 4.40%?

Proposition 122 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes concerning legal regulated access to natural medicine for persons 21 years of age or older, and, in connection therewith defining natural medicine as certain plants or fungi that affect a person's mental health and are controlled substances under state law; establishing a natural medicine regulated access program for supervised care, and requiring the department of regulatory agencies to implement the program and comprehensively regulate natural medicine to protect public health and safety; creating an advisory board to advise the department as to the implementation of the program; granting a local government limited authority to regulate the time, place, and manner of providing natural medicine services; allowing limited personal possession, use, and uncompensated sharing of natural medicine; providing specified protections under state law, including criminal and civil immunity, for authorized providers and users of natural medicine; and, in limited circumstances, allowing the retroactive removal and reduction of criminal penalties related to the possession, use, and sale of natural medicine?

Proposition 123 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes concerning statewide funding for additional affordable housing and, in connection therewith, dedicating state revenues collected from an existing tax of one-tenth of one percent on federal taxable income of every individual, estate, trust, and corporation, as defined in law, for affordable housing and exempting the dedicated revenues from the constitutional limitation on state fiscal year spending; allocating 60% of the dedicated revenues to affordable housing financing programs that will reduce rents, purchase land for affordable housing development, and build assets for renters; allocating 40% of the dedicated revenues to programs that support affordable home ownership, serve persons experiencing homelessness and support local planning capacity; requiring local governments that seek additional affordable housing funding to expedite development approvals for affordable housing projects and commit to increasing the number of affordable housing units by 3% annually; and specifying that the dedicated revenues shall not supplant existing appropriations for affordable housing programs?

Proposition 124 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes concerning increasing the number of retail liquor store licenses in which a person may hold an interest. and. in connection therewith, phasing in the increase by allowing up to 8 licenses by December 31, 2026, up to 13 licenses by December 31, 2031, up to 20 licenses by December 31, 2036, and an unlimited number of licenses on or after January 1, 2037?

Proposition 125 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes concerning the expansion of retail sale of alcohol beverages, and, in connection therewith, establishing a new fermented malt beverage and wine retailer license for off-site consumption to allow grocery stores, convenience stores, and other business establishments licensed to sell fermented malt beverages, such as beer, for off-site consumption to also sell wine; automatically converting such a fermented malt beverage retailer license to the new license; and allowing fermented malt beverage and wine retailer licensees to conduct tastings if approved by the local licensing authority?

State Ballot Measures Proposition 126 (STATUTORY)

Shall there be a change to the Colorado Revised Statutes concerning authorization for the third-party delivery of alcohol beverages, and, in connection therewith, allowing retail establishments licensed to sell alcohol beverages for on-site or off-site consumption to deliver all types of alcohol beverages to a person twenty-one years of age or older through a third-party delivery service that obtains a delivery service permit; prohibiting the delivery of alcohol beverages to a person who is under 21 years of age, is intoxicated, or fails to provide proof of identification; removing the limit on the percentage of gross sales revenues a licensee may receive from alcohol beverage deliveries; and allowing a technology services company, without obtaining a third-party delivery service permit, to provide software or a digital network application that connects consumers and licensed retailers for the delivery of alcohol

Dolores County Ballot Issue 1A: Lodging Tax to Support Local Workforce

SHALL DOLORES COUNTY TAXES BE INCREASED BY \$234,250.00 ANNUALLY COMMENCING JANUARY 1, 2023 FROM A TWO PERCENT (2%) LODGING EXCISE TAX ON THE RENTAL FEE, PRICE, OR OTHER CONSIDERATION PAID OR CHARGED FOR THE LEASING, RENTAL, SALE OR FURNISHING OF A ROOM OR ACCOMMODATION FOR A SHORT-TERM PERIOD (A PERIOD OF LESS THAN 30 CONSECUTIVE DAYS) IN DOLORES COUNTY, EXCLUDING THE TOWN OF RICO THAT CURRENTLY HAS ITS OWN ADOPTED LODGING TAX, WITH TEN PERCENT (10%) OF SAID REVENUE USED FOR ADVERTISING AND MARKETING LOCAL TOURISM; THIRTY PERCENT (30%) OF SAID REVENUE USED TO ACQUIRE, CONSTRUCT, MAINTAIN, ENHANCE, RENOVATE, RELOCATE, IMPROVE PROMOTE, SUPPORT AND FUND, HOUSING AND CHILDCARE FOR THE TOURISM-RELATED WORKFORCE AND OTHER WORKERS IN THE COMMUNITY; AND SIXTY PERCENT (60%) USED TO HELP FACILITATE AND ENHANCE THE VISITOR EXPERIENCE THROUGH FUNDING OF ROAD MAINTENANCE, EMERGENCY SERVICES, THE DEVELOPMENT OF SIGNAGE, TRAILS, AND TRAILHEADS, WITH ALL SUCH OPERATING AND CAPITAL EXPENDITURES AND PROPORTIONS DETERMINED BY THE COUNTY AND RESTRICTED TO THE USES SET FORTH HEREIN, AND SHALL THE FIRST YEAR REVENUES, AND WHATEVER ADDITIONAL AMOUNTS ARE RAISED ANNUALLY THEREAFTER, INCLUDING BY RETURN ON INVESTMENT, BE COLLECTED AND SPENT AS A VOTER APPROVED REVENUE CHANGE NOTWITHSTANDING ANY LIMITATION OR CONDITION UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION OR ANY OTHER PROVISION OF LAW?

Dolores County Ballot Issue 1B: Creation of a Countywide Retail 2.9% Sales Tax

SHALL DOLORES COUNTY TAXES BE INCREASED \$924,187.00 ANNUALLY BEGINNING JANUARY 1, 2023 AND BY SUCH AMOUNTS AS ARE RECEIVED IN ANY YEAR THEREAFTER BY THE IMPOSITION OF A 2.9% COUNTYWIDE SALES TAX TO BE USED TO FUND COUNTY SERVICES AND CAPITAL EXPENDITURES WITHIN DOLORES COUNTY AND BE IMPOSED AS FOLLOWS: A SALES TAX AT A RATE OF 2.9% ON THE SALE OF TA<mark>NGIBLE PERSONAL PROPERTY</mark> AT RETAIL AND THE FURNI<mark>SHING</mark> OF SERVI<mark>CES IN TH</mark>E COUNTY PROVIDED THAT THIS QUESTION DOES NOT AUTHORIZE THE COUNTY TO INCREASE ANY OTHER TAX, INCLUDING PROPERTY TAXES; AND SHALL ALL REVENUE OF SAID SALES TAX, INCLUDING RETURN ON INVESTMENT THEREON, CONSTITUTE VOTER-APPROVED REVENUE CHANGES AND BE COLLECTED AND SPENT BY THE COUNTY WITHOUT REGARD TO ANY SPENDING. REVENUE-RAISING, OR OTHER LIMITATION CONTAINED WITHIN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION OR ANY OTHER PROVISION OF LAW?

DOLORES COUNTY SCHOOL DISTRICT RE-2J BALLOT ISSUE 5A

SHALL DOLORES COUNTY SCHOOL DISTRICT RE-2J DEBT BE INCREASED UP TO \$10,348,931 WITH A REPAYMENT COST OF UP TO \$17,390,000, AND SHALL DISTRICT TAXES BE INCREASED BY UP TO \$865,000 ANNUALLY BY THE ISSUANCE OF BONDS TO PROVIDE LOCAL MATCHING MONEY REQUIRED FOR THE DISTRICT TO RECEIVE \$12,648,692 IN AWARDED "BEST" GRANT FUNDS WHICH ARE NOT REQUIRED TO BE REPAID (BUT WILL NOT BE RECEIVED BY THE DISTRICT WITHOUT APPROVAL OF THIS BALLOT ISSUE) TO ENHANCE THE SAFETY, SECURITY AND HEALTH OF DOVE CREEK ELEMENTARY STUDENTS BY FINANCING THE COSTS OF:

CONSTRUCTING A REPLACEMENT ELEMENTARY BUILDING WHICH INCLUDES AN ENLARGED KITCHEN AND COMPETITION GYMNASIUM/ALL-PURPOSE ROOM FOR CAMPUS-WIDE USE, AS WELL AS LIBRARY AND INSTRUCTIONAL SPACE IMPROVEMENTS;

MAINTAINING AND IMPROVING THE MEMORIAL HALL GYMNASIUM TO PRESERVE HISTORY AND PROVIDE BETTER COMMUNITY ACCESS; AND

- REMOVING THE EXISTING ELEMENTARY SCHOOL BUILDING AND THE OLD HIGH SCHOOL BUILDING (WHICH IS THE CLASSROOM AREA BEHIND MEMORIAL HALL GYMNASIUM) TOGETHER WITH SITE PRESERVATION RELATED TO SUCH REMOVAL;

THROUGH GENERAL OBLIGATION BONDS WHICH BEAR INTEREST, MATURE, ARE SUBJECT TO REDEMPTION, WITH OR WITHOUT PREMIUM, AND ARE ISSUED AT SUCH TIME, AT SUCH PRICE (AT, ABOVE OR BELOW PAR) AND IN SUCH MANNER AND CONTAINING SUCH TERMS, NOT INCONSISTENT WITH THIS BALLOT ISSUE, AS THE BOARD OF EDUCATION MAY DETERMINE; AND SHALL AD VALOREM PROPERTY TAXES BE LEVIED WITHOUT LIMIT AS TO THE MILL RATE TO GENERATE AMOUNTS, NOT TO EXCEED THE AMOUNTS SET FORTH ABOVE, SUFFICIENT IN EACH YEAR TO PAY THE PRINCIPAL OF AND INTEREST ON SUCH BONDS AND TO FUND ANY RESERVES FOR THE PAYMENT THEREOF?
